# Scope of Journal

#### Review Process

- 1. All submissions will undergo to a rigorous double-blind peer review process, including desk review, similarity and plagiarism analysis, and an Al-assisted text evaluation.
- 2. Manuscripts should be concise, well-structured, and interconnected, employing academic writing rather than journalistic styles.
- High-quality and innovative research must include sections such as an introduction, methodology, theoretical framework/background, findings, analysis/discussion, policy proposals, and conclusion. The conclusion should also explore broader impacts and implications of the findings.
- 4. Submissions meeting the journal's scope and quality criteria will undergo a minimum of two (and/or three) double-blind subject expert peer reviews that will evaluate whether it offers theoretical/analytical insights, robust argumentation, relevant academic citations, and well-substantiated conclusions.
- 5. A common issue with submissions is the lack of theoretical integration. Merely citing a theory without proper application or integration does not constitute a theoretical contribution or a sound theoretical basis. Similarly, replication or summaries of prior work without offering novel insights are insufficient. While replication studies have value, JASS prioritises innovative contributions.

#### **Submission Procedure**

JASS does not have Article Processing Charges (APCs) nor submission charges. It offers no waiver support. Author/s are required to email soft copies in MS Word format, along with their brief introduction, complete contact details, and electronically signed *Authorship, Conflict of Interest & Originality Declaration* form (see Appendix, form is downloadable from website).

# Supplementary Material Guidelines

- 1. Provide complete references for all figures, graphs, images, maps, and tables.
- 2. Ensure images and maps have a resolution of 300–600 dpi and are submitted in .tiff, .jpeg, or bitmap format. For figures and graphs, include files with editable text to allow formatting adjustments to align with the journal's style.
- 3. Use only royalty-free images or obtain explicit consent from the original owner for reuse.

#### **Peer Review Process**

#### **Step 1: Initial Screening for Similarity and AI Evaluation**

**Similarity Detection**: All submissions are screened using similarity detection software to ensure compliance with the journal's zero-tolerance plagiarism policy. Submissions with a similarity index above 19% are automatically rejected.

**Al Evaluation**: An Al-assisted evaluation is conducted to detect content generated or heavily influenced by Artificial Intelligence (Al). Submissions with an Al-generated content score exceeding 21% are flagged. This ensures originality while accounting for possible inaccuracies in Al detection tools.

#### **Step 2: Desk Review**

Submissions passing the similarity and AI evaluation proceed to a thorough desk review.

Manuscripts are evaluated for clarity, conciseness, and adherence to academic writing standards. They must include sections (but not necessarily limited to) such as:

- Introduction
- Methodology
- Conceptual Framework/Background
- Findings
- Analysis/Discussion
- Policy Proposals
- Conclusion (including broader impacts and implications of findings).

This review also assesses whether the manuscript falls within the thematic scope of the journal, and adheres to the journal reference standardisation and syntax requirements.

**Withdrawal**: Manuscript withdrawal may be requested within seven days of submission, subject to the editorial board's discretion and formal confirmation. A withdrawal request becomes effective only upon receipt of an official letter/email from the Editor-in-Chief. To safeguard workflow integrity, withdrawal is strictly prohibited once the manuscript has entered the peer-review stage.

#### **Step 3: Double-Blind Peer Review**

Shortlisted manuscripts are subjected to a double-blind peer review by at least two subject experts. These reviews assess whether the manuscript:

- Demonstrates a clear theoretical/analytical contribution.
- Exhibits robust argumentation supported by relevant academic citations.
- Provides findings that add value and are presented in a structured manner.
- Common desk review issues include:
  - Lack of theoretical integration: Citing theories without proper application does not constitute a theoretical contribution.
  - Replication or summary of prior work: Manuscripts must provide novel insights rather than restate existing knowledge. While replication studies hold value, JASS prioritises originality and innovation.
- Reviewers may recommend approval, rejection, or revisions (major or minor).
- Manuscripts requiring revisions in track mode may undergo multiple rounds to meet the journal's quality standards.

#### **Step 4: Final Decision**

Decision of publication rests with the journal's Editorial Board based on the recommendations of the peer review evaluations. However, CASS reserves the right to reject a submission at any stage from being published.

#### **Note**

CASS encourages authors to ensure their manuscripts:

- Are well-structured, concise, and written in an academic style.
- Follow the journal guidelines.
- Offer original, high-quality, and forwarding-looking research.
- Include all required sections and a strong conclusion highlighting the broader implications of the findings.

#### Mandatory Documents

The following documents must be emailed before the Desk Review process can be initiated:

- 1. Authorship, Conflict of Interest & Originality Declaration
- 2. Full-length article, including an abstract of 150 words, in MS Word format.
- 3. Author(s)' 30-word introduction, complete email and postal contact details and current organisational affiliation.

#### Note:

- JASS does not charge a publication fee from authors. Authors of published scholarly articles are paid a modest honorarium.
- JASS is an open-access journal. All published work is freely available to read, download, copy, distribute, print, search, or link to the full text of articles, index, or use for any lawful purpose.
- Copyright: JASS, as the publisher, holds the right of first publication. Authors retain rights to use the substance of their work in future endeavours, provided it is not offered for sale and includes proper attribution to the journal.

#### Editorial & Review Process

- 1. Only original and unpublished papers are accepted for consideration.
- 2. Submissions undergo initial Desk Review, where they are screened using plagiarism/Al detection software. Referenced/cited content should not exceed 19% of the paper. The journal has a zero-tolerance plagiarism policy for plagiarism. An Al-assisted evaluation is conducted to detect content generated or heavily influenced by Artificial Intelligence (Al). Submissions with an Al-generated content score exceeding 21% are flagged. This ensures originality while accounting for possible inaccuracies in Al detection tools.
- 3. Submissions shortlisted by the Editorial Board proceed to two double-blind peer reviews. During this process, papers may be rejected, accepted with minor or major revisions. Several rounds of revisions may be required. Peer review timelines vary depending on reviewer availability, area expertise and responsiveness. Peerapproved scholarly articles are edited for content, language, and grammar. Editorial and review decisions are final.

- Manuscripts: 4,500–5,000 words.
- Book Reviews: 1,000 words (limited to reviews of recent books on aerospace, security, or related topics).

#### Abstract and Keywords

- **Abstract**: A concise narrative summarising the title, theme, objectives, data sources, and major findings (150 words, in italics).
- Include keywords capturing the paper's main aspects.

#### Paper Structure

Use the following structure for manuscript submission:

- Title (Roboto 14 pt, Bold)
- Author's name (italicised bio-note in footnote, 30 words)
- Abstract (italics)
- Keywords

#### Abbreviations, Glossary, Tables, and Figures

- Provide a list of abbreviations/acronyms and a glossary of terms, especially those in native languages.
- Present tables and figures on separate pages. Each figure or table must be labelled, include captions above, and provide sources below (in italics).
- Submit high-resolution JPG or PDF files for all figures.
- Ensure content is legible in black-and-white print.
- Complete references of all figures, graphs, images, maps, and tables need to be provided.
- İmages/maps should have a resolution of 300–600 dpi and sent as .tiff, .jpeg, or bitmap. All images should be royalty-free or have the original owner's consent for reuse.

#### References

- References are included as footnotes following the Chicago Manual of Style (17<sup>th</sup> Edition, Full Note) format.
- A separate bibliography is not required.
- For all cited materials, ensure accuracy, completeness, and proper formatting.
- Use auto-numbered footnotes for all citations and references.

#### **Direct Quotes**

Short and long quotations (30 words or less) should use single quotation marks and include a footnote reference.

#### **Paraphrasing**

Always credit the original source when paraphrasing. Failure to attribute sources constitutes academic dishonesty.

#### <u>Acknowledgements</u>

Acknowledgments may be included at the end of the paper (maximum 30 words). Authors may mention grants, funding bodies, or donors supporting the research.

#### Formatting Guidelines

- Font: Roboto, 11 pt (Body Text), 14 pt (Title), 12 pt (Headings/Sub-headings).
- Spacing: 1.2 line spacing, justified alignment.
- Spellings: Use British English.


